1. **Title of the Practice:** Adoption of Downtrodden University Neighborhood

2. **Objectives of the Practice:** Since the Universities has been mandated to take the responsibility of the communities which are downtrodden and lack the amenities which are required for the normal day to day life. The Directorate initiated the practice in title with below mentioned objectives:

- Advocacy and Awareness
- Establishment of Skill Trainings
- Development of Entrepreneurship
- Health & Hygiene Awareness & betterment
- Counselling & Guidance

3. **Context:** Like others, University of Kashmir is engaged in teaching, research and outreach or Extension. The University would be considered successful only when it has an equal focus on all the three activities. Generally, outreach activities are less emphasized than the teaching and research by the Universities. Lack of emphasis on outreach activities leads to disconnect with an important section of the society i.e. socially and educationally backward. The Universities are required to provide equal opportunities to one and all in the society rather should strive more for the unprivileged classes of the society. Therefore, outreach activities call for an attention of the Universities in the country. Outreach activities involve reaching the society particularly the unprivileged class by providing avenues for continuing education while working, raising awareness about various social, economic and technological issues and about skill development of youth in order to enhance their employability. These avenues have special importance in view of the unique state setting which is suffering from large scale unemployment among the youth. University of Kashmir is well aware of its responsibility of outreaching the society particularly the unprivileged class. In order to engage outreach activities,

the most prominent step in this regard has been the establishment of area-based community Development approach for the Adoption of Downtrodden communities in the near vicinity of the Main campus. Three Model Areas were identified in this case viz Mir Behri Dal; Rakhi Zakura; and Shanpora, Habak, all nearer to the University main Campus.

### ***Challenging issues in implementation of the Programme***

Every project or initiative takes a steady path to reach to the targets. Here due to diversity in the age groups of the populace, and certain parameters like accessibility to the site, communication inhibitions of the populace and social stigmatization to reveal the miseries and difficulties realistically created certain challenges to make inroads in the adopted areas

**4.The Practice:** If the University system has to discharge adequately its mandate to the entire education system, industry and to the society as a whole it must assume Community development as an important responsibility. The University of Kashmir through Directorate of Lifelong Learning has offered plethora of professional/ vocational courses both within the University campus and in the various adopted communities in near vicinity of university for the overall betterment and development of these area.

We planned these courses after a preliminary survey and consultation with various stakeholders in a given area. The need assessment survey offers the Directorate insights into the most critical needs of the youth. The Directorate has thus responded to the diverse aspirations of the youth and other learners; such aspirations range from employability in the local industry, market and development of entrepreneurship, and other livelihood earning ventures together with Health & Hygiene and counselling. The Directorate has opened up a model window for unemployed youth in the downtrodden communities which are in neighborhood and near vicinity of the University by introducing the appropriate job oriented, income generating, skill-based courses over the years in different sectors. As mandated by University Grants Commission reproduced as '*Lifelong Education as the cherished goal of the educational process which presupposes universal literacy, provision of opportunities for youth, housewives, agricultural and industrial workers and professionals to continue the education of their choice at the pace suited to them*'. In tune with the Policy, Directorate inducted many programmes in such adopted areas with the inclusion of local populace.

With regard to the limitations and constraints of the adopted Programme. Certain observations have been calculated on the basis of the overall tangible field in-depth work. Since the UGC is the most important Central regulatory body in the higher education with a mandate to promote, coordinate and maintain standards in higher education, there are other regulatory bodies as well to check & balance the things. Similarly, in case of the mandate of university to link and assists the local populace, adoption of areas have taken a leap. On the similar analogy, any Regulatory body need to be framed to make progression in such domain with considerable outcome

**5. Evidence of Success:** The success of the programme-initiated lies with the outcome. the basic outcome with regard to the objectives are depicted below.

- **Advocacy and Awareness:** Participatory Rural Appraisals, One to One meeting, Brainstorming sessions, expert Guest Lectures to the target group.
- **Establishment of Skill Trainings:** Development Skill centre in the trades of Papier Machie (103 Candidates trained), Self-employed Tailor (25 Candidates Trained) & Bridal mehndi (50 Candidates Trained) in three adopted areas Mir Behri Dal; Rakhi Zakura; and Shanpora, Habak respectively all in the near vicinity of University of Kashmir
- **Development of Entrepreneurship:** The progression of the trained Clientele became self-sustained in terms of their earning livelihood, thus developed Entrepreneurship by way of self-help groups
- **Health & Hygiene Awareness & betterment:** Health camps and awareness generation Programmes

**6. Problems encountered and Resources Required:**

- Identification of Real Beneficiaries
- Lack of Motivation among the Community Members
- Lack of transportation / vehicles for the staff
- Mobilization of equipment / lab gadgets to the community setup
- Lack of University owned space like Skill centre / Community College/ Lab/ Workshop in the adopted communities
- Being the subject in Non-formal Education System, there is Lack of empathy / recognition of extension-based community work in the University System where research and teaching is prioritized in every realm
- Limited financial budget for such programmes

Sub: Adoption of Habak Shanpora and Rakh-e-Zakura (Srinagar) under Area Based Community Development (ABCD) approach by the Directorate of Lifelong Learning University of Kashmir.

The Directorate has oriented its initiatives towards socio-economic, educo-developmental appropriateness of the society under Area Based Community Development Approach (ABCD). It created flexible, affordable, adaptable, accessible, inclusive and outcome-based pathways by de-caging its initiatives beyond the four walls of the university as per the changing requirements of socio-economic reality, world of world and real-life situations under the umbrella of Extension and continuing education. The introduction of wide range of professional / vocational, skill based, job-oriented courses for entrepreneurship development, income generation have yielded tangible results and evoked tremendous response from all walks of life. There remains a constant pressing demand from the youth of the entire valley for conduct of such courses. Besides, the capacity building programmes, quality of life improvement programmes, bridge courses, individual interest promotion programmes, equivalency programmes, awareness generation programmes, medical and health awareness camps have been instrumental in promoting capacities of community to the needs of day-to-day quality life. The functioning of the Directorate of Lifelong Learning is to integrate and intermingle with society which it serves or within which it is located and workout programmes as per dimensions of their felt needs.

The Directorate of Lifelong Learning has a mandate of UGC for active community engagement, improving social responsibility for the betterment and welfare of the society and promote linkage between local community and University thereby making education more relevant to dynamic needs of Community. In the light of above mandate, the Directorate adopted a nearby area of Srinagar namely Mir Behri Saida kadal Dal situated around 2 kilometres distance from the University. In view of the poor status of the area especially in education, health and hygiene, socio economic condition and other aspects of life. The Directorate organised various awareness programmes related to Health and Hygiene, career counselling, livelihood skills, skill development courses and entrepreneurship development programmes for the overall development of the said community. The Directorate completed training of around 500 candidates in Papier Machie Art, Computers, Transformer Fabrication etc which resulted in self-employability, income generation and confidence development among maximum number of pass-out trainees.

**Brief Background of the area:**

The Directorate now intends to Adopt Habak Shanpora Hazratbal and Rakhi-Zakura. The existing state of living conditions of these two areas speak a volume about their socio-economic and educational backwardness. Literacy, a stepping stone for all the developments, is absolutely low in the area and general understanding about contemporary issues like Health Care, family welfare, Health / Hygiene, Sanitation, Literacy, Skill Development and entrepreneurship development are extremely poor. Besides there are inadequate basic civic amenities in the area and the people suffer from cumulative diseases like mal-nutrition, waterborne diseases, load of infections, poor mother and child care. The main occupation of the area in question is sozni art, shawl weaving, copper utensil engraving art. Besides, the people consist of marginal farmers, share croppers, landless labourers, artisans, occupational castes and other service occupations (low paid occupations) unskilled and semi-skilled workers, carnal wage labourers, petty trading, driving, hawking, fruit and vegetable selling. The status of the women is very low. They are asset-less, illiterates, unemployed, destitute yet overworked,

2. To initiate/ introduce skill based, career/job oriented and income generating activities for helping clientele to increase their income and improvement to standard of life;
3. Integration between the society and university for overall socio-economic development of the community;
4. To foster the development of critical and creative thinking and problem solving etc.

**Target Groups/ Clientele:**

1. Illiterate youth, school dropouts, semi-literates, neo literates, education learners;
2. Volunteers, activists, social workers, instructors, senior citizens, stake holders;
3. Field functionaries of different Departments like Social Welfare Department, rural Development Department, Srinagar Municipal Corporation, Department of Health and other developmental agencies / departments.
4. In service people, educated unemployed youths, semi-skilled etc;
5. Women/ widows, disadvantaged groups, labourers, artisans, low-income groups, physically challenged, transgenders etc;

**Methodology:**

1. Lecture online as well as off line;
2. Practical's;
3. Workshops, webinars;
4. Orientations/ trainings about the digitalisation of data base;
5. Demonstrations through various audio-visual aids;
6. Studies, projects and surveys;
7. Camps, picnics and cultural programmes etc;
8. Programming through internet etc.

 To begin with, the Directorate organised one day orientation programme for the inhabitants of the Habak Shanpora area of Hazratbal Srinagar on 06<sup>th</sup>, December 2022, participated by all sections of the society including youth, women, senior citizens, semi literates, semi-skilled and other representatives of the area and the programme was graced by the Hon'ble Vice Chancellor University of Kashmir. The Hon'ble Vice Chancellor interacted with the people extensively and as per the demand of the locals and in view of the pathetic conditions of the area, the Hon'ble Vice Chancellor urged the Directorate to adopt the area and start some community developmental programmes there as per the mandate of the UGC and the felt need of the community. The representatives of the area requested to start some vocational / skill-based courses in order to enhance the skill competency in different trades. In this regard an application from the local village Community Head has been received by this Directorate regarding the conduct of cutting and Tailoring Course which has been forwarded by Hon'ble Vice Chancellors office to the Directorate of Lifelong Learning Vide your office No: 48 / VCCF Dated 19/12/12. (Copy enclosed).

The Directorate formally adopted two villages namely Habak Shanpora and Rakhi-Zakura. The Directorate underwent a primary survey of the area regarding their felt needs and decided to initiate two vocational courses namely "Self Employed Tailoring" at Habak Shanpora and "Bridal Mehandi Designing" at Rakhi-Zakura.
