Lifelong Learning

Lifelong Learning is known as the voluntary or self-motivated learning activity which is undertaken throughout the life. It is a process of constant learning and development that incorporates professional development, whether in a formal or informal way so as to create an enriching and dynamic society. The main focus of this activity is to upgrade the skills to develop self-confidence and also to involve oneself in the community through social networking and upliftment programmes. The main characteristics of lifelong learning may be described as to acquire and apply the skills to promote the creativity, knowledge and personal fulfilment. It can also be taken as an approach to learning which is more flexible, critical and capable and above all, a sort of learning which exercises tolerance, mutual respect and understanding for each other. It is important to form a lifelong learning society in which people can freely choose learning opportunities during their lives and proper recognition is accorded to those learning achievements. It also includes the skills, knowledge, attitudes and behaviours that people acquire in their day to day life experiences. It is undertaken throughout the life with the aim of improving knowledge, skills, and competence within a personal, civic, social and employment related perspective to promote the development of knowledge that will enable each citizen to adapt to the knowledge based society and actively participate in all spheres of social and economic life. Learning opportunities should be available to all citizens on an ongoing basis i.e each individual should have learning pathways suitable to his needs and interests at all stages of his life.



Lifelong learning also provides second chances to update basic skills and offer learning opportunities at more advanced levels. The idea of lifelong learning should be facilitated by bringing together formal education and vocational education in central aspects of different policies such as education, youth, employment and research and whose core values lies in learning and exploring which are coupled with benefits for the mind, body and spirit making it incredibly powerful tool for personal transformation and enhancement. 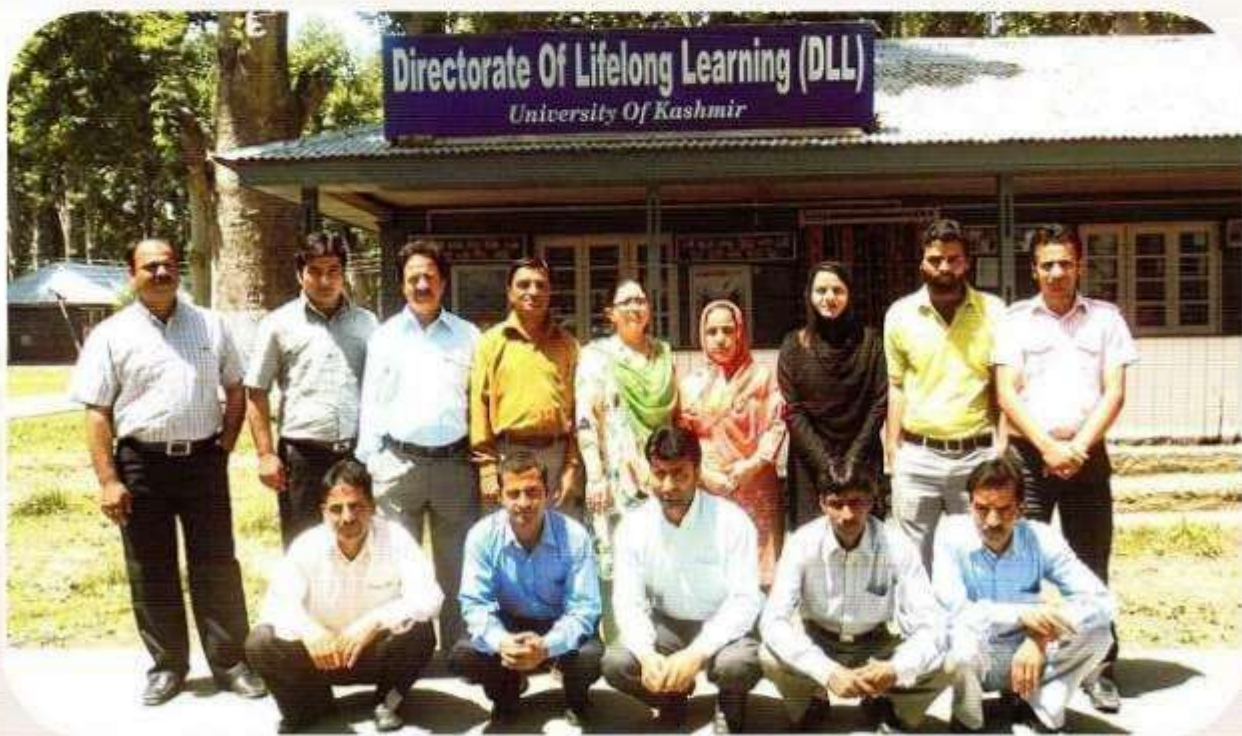

Profile

Established in 1978, the Directorate of Lifelong Learning (DLL), University of Kashmir serves to carry the positive change in the lives of common masses of the State by providing multitude of diverse programmes. The main thrust of such programmes is to provide a wide variety of lifelong learning opportunities to all sections of society. These include continuing education courses both



University based and community centred equivalency programmes, quality life improvement programmes, individual interest promotion programmes, vocational education, skill trainings, induction of sensitization programmes which also include seminars, sensitization programmes, awareness drives and workshops etc. The Directorate especially endeavours to renew the relevance, interest and economic potential of youth through its vision. Our thrust is to help them to set up income generation units and to promote their professional abilities through required inputs.

The role and importance of lifelong learning has increased in recent times due to several socio-economic factors. In a technology driven knowledge based competitive economy; the landscape of learning is fast changing in India. The growth of Indian economy and tremendous expansion of Information Communication Technology with the rapid globalization have all been instrumental in bringing changes in the job skills so that workforce keeps on learning and updating their skills to be globally competitive. The country's

economic performance depends critically on access and adoption of new technology and the acquired skills to compete in the global economy equipping the people with learning and training opportunities. In this process, the University of Kashmir through Directorate of Lifelong Learning has been playing important role in offering the skill based vocational programmes and courses.

In the wake of growing demand for skilled and trained workers, the Directorate has focused on developing technical, entrepreneurial and professional skills among students to create skilled human resource base and to cope up with the demand of fast changing professional world. Considering all the above features, the Directorate has been conducting various professional and vocational courses which include various certificate and diploma courses like "Cisco Certified Network Associate (CCNA) I,II", "Cisco Certified Network Associate (CCNA) III, IV", "Course in Computer System Engineering", "Computer Hardware and Networking", "MS-Vb.net", "Course in Web Designing", "Basic Computer and Internet", "Photography", "Videography", Public Relations, "Course in Mobile Phone Repairing", "Certificate Course in Electric and Electronics", "Food Technology and Catering", "Course in Plumber and Fitter", and "Electrician Course". The Directorate has to start various diploma courses in the disciplines like Clinical Chemistry, Hospitality and Management, Tourism, Computer Applications, Information Technology, Rural Development and Food and Vegetable Processing etc. These programmes are usually executed through a Community Development Centres in various Districts of the valley. Since the Directorate of Lifelong Learning offers need based courses, there is always scope to add more and more programmes which are specifically as per the community needs. When compared to conventional teaching Departments, the Directorate has many advantages. The focus on continuing education for the changing world of work takes a big leap in the continuing education. Thus it provides a series of continuing education courses/ trainings/ programmes to equip the talent with the self employment skills to lead them to be the best entrepreneurs of the future. The Directorate has been playing a key role in focusing the practical needs of the marginalized and weaker section of the society through its diverse outreach programmes thereby developing a meaningful and sustained rapport between the University and the society. The Directorate of Lifelong Learning impress upon the extension programmes which are qualitatively different from other organizations especially NGOs and other non-governmental agencies. Hence the Directorate usually takes up the activities with the purpose of developing innovative models of extension. These activities are well planned with the active participation and collaboration of the University Departments, Community Departments and are always student friendly.

Throughout the session (2010), the Directorate has been actively involved in offering multiple programmes recognised by University Grants Commission (UGC) and Rehabilitation Council of India (RCI) in order to help the community to plan and prepare critical understanding of requirements of the population. The Community Development Centres established by the Directorate are actively providing newer opportunities based on possible interventions and inclusions. In today's world of modernization where each day is witnessing new innovations, inventions and rapid processes of development, it becomes absolutely imperative to adapt, learn and thus enrich our lives to compete in the world of competition. Having the diversity in its programmes, the Directorate is holding counselling cum coaching programmes for various competitive examinations, and has initially focused on AIEEE and AIPMT only. This is to build the capacity and competence among the young boys and girls for competitive examinations at State and National level. With this objective, the Directorate conducted a series of coaching cum counselling programmes with regards to AIEEE during 2010. This programme was conducted in collaboration with National Institute of Technology (NIT) Srinagar and was first of its kind in the valley. It resulted beneficial for the student community and ultimately brought laurels to the University when few of the students bagged the ranks in this examination at State Level. The success of the programme prompted the Directorate to conduct counselling cum coaching for the present session (2011) also.

The Directorate of Lifelong Learning in addition to this also provides trainings in various skill based, job oriented professional and income generation courses for the aspirants especially for the youth of region. These programmes usually include the present day need based trades and courses. Furthermore, various academic certificate courses and other diploma courses are also being organized and conducted by the Directorate as an initiative for the community development. During this year approximately 2000 students from various Districts of the valley were trained by DLL while the trainings were imparted in concerned ITIs and polytechnics of the State. The effort has been highly appreciated by the State Government, public as well as by the students and other agencies at National and State level.

Various skill oriented programmes were carried out by the Directorate during the session 2010-11 and the successful candidates were felicitated by DLL in the gala function entitled "The Certificate Distribution" which was held on 24th June 2010. The main objective of the function was to motivate more and more youth at secondary level for trainings in such professional courses (in addition to other academic programmes which they already pursue through formal mode). The main objective is to prepare the workforce for the

Industries, Corporates and other Government and semi- Government organizations at the State and National level. This programme was attended by various Cabinet Ministers of J&K State, Worthy Vice Chancellor of the Kashmir University, Registrar, Deans and Heads of various Departments, Directors of various Directorates, Heads of various administrative organizations, members from the civil society and local administration. The Directorate conducted various outreach activities in terms of exchange/ exposure visits, explorative ventures, advocacy policy meetings and grass root level community interactions for the betterment of un-reached masses. These activities were focused to expand the people's capabilities to become increasingly aware about different disadvantaged areas and enhanced scientific knowledge to combat the adverse circumstances in order to improve the quality of living. Such programmes resulted greater acceptance and implementation of message meant for human welfare. For such activities DLL works in collaboration with the District Administration, agencies at the Government and semi-Government levels, Non-Governmental functionaries and other concerned organizations at the State and National level.

The programmes of the Directorate always entail the objectives outlined by the UGC for lifelong learning at large. In other words, the University system has to prepare the student to be a lifelong learner, only then the youth will be able to sustain the knowledge and skills at an international benchmark level. Lifelong learning systems have to integrate between the formal and non-formal system of education, as such DLL opens its doors to adult learners for lifelong learning programmes and plays a dynamic role in the development of the human resource, especially professional manpower in the area of lifelong learning.

Since lifelong learning has become a fundamental goal of recent educational policies, it is often advocated as a channel to achieve socio-economic development and a tool for promoting knowledge. DLL has focused on deploying lifelong learning as a discipline of study and field of practice and has been making concrete efforts to reach out to larger sections of community especially to deprived groups through its multi-innovative programmes. Thus considering a wide range of on-campus and off-campus activities of DLL, it won't be out of way to recognize the Directorate as a focal agency with a catalytic role in the development of academic and technical resource support for community based activities in collaboration with University Departments and State level colleges of academic and professional level. It has also developed a network with Government and Non-Governmental agencies, National and International Organizations as well as industries and corporates in the best interest of the people.

Thrust Areas

The thrust areas of DLL is to reach out to larger sections of the community for promotion of lifelong learning as a part of total education programme through formal, non-formal and extension activities in the frame work of teaching, training, research and awareness for the development of socio-economic and knowledge based society. Initiatives are taken up for linking the University with the Government, semi- Government organizations and to provide the welfare schemes in terms of self employment and personal upliftment of the community especially the youth. Hence such endeavours are to be achieved through certain components of lifelong learning which mainly comprise:

- d) Workshops/ Seminars/ Trainings
- e) Community Outreach Activities

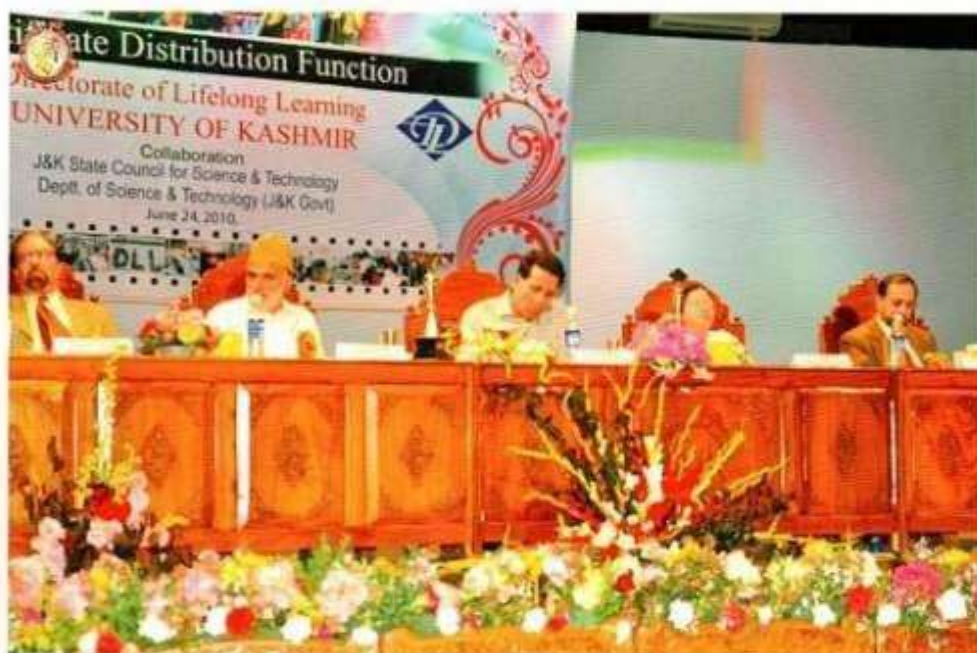
Counseling before onset of various Professional and Vocational Courses

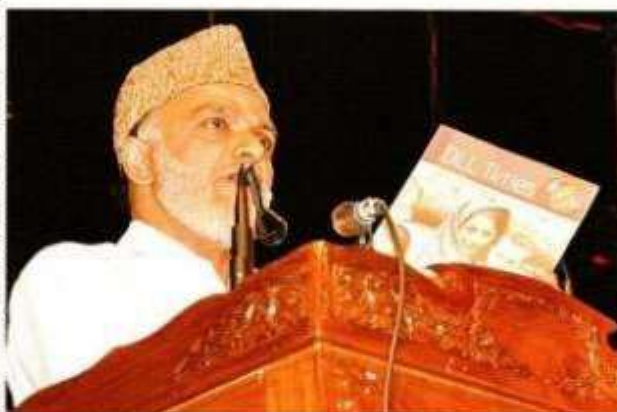

Programmes and Courses for Children with Special Needs on Track

Rehabilitation programs should make it possible for Disabled persons to take part in designing and organizing the services that they and their families consider necessary. Procedures for the participation of disabled person in the decision- making relating to their Rehabilitation should be provided for within



the system. Efforts should be to augment and develop rehabilitation services integrated with other services to make them more readily available. The essentials of rehabilitation would consist of efforts which minimize the adverse impact of disability and promote the latent abilities to the fullest extent possible. By providing rehabilitation services and support, number of disabled can not only effort independent living but can also contribute to the society in several ways. History is too replete with examples of many such persons. The famous devotional poet Surdas being totally blind; president Roosevelt, Orthopaedic handicapped; Stephen Hawking, the world famous scientist confined to wheel chair; Hellen Keller, the deaf and blind who is an icon of inspiration to the disabled all over world ; Louise Braille, the blind whose discovery of Braille enabled the blind to read and write; Beethoven, whose contribution to music is unique despite his deafness, and many more are shining examples of inspiration for the people with disabilities. Taking the list of such inspiring stars into consideration, Directorate of Lifelong Learning (DLL) has initiated various programmes that will take care or support this class of

community which also differs from other types of health care or rehabilitation in that the goal is not to cure the illness or fix the disability, but rather to provide support and to create an environment in which the individual can attain and maintain optimal functioning, living, and well-being. To begin with the Directorate has started the phase-wise Short term and long term training programmes in all the Districts of the Kashmir valley.

This year the Directorate is going to start Diploma in Community Based Rehabilitation (CBR) with the following objectives:

1. To understand and assist planning and implementation of Community Based rehabilitation.
2. To identify persons with disabilities and their rehabilitation needs.
3. To make functional assessment of individuals with disabilities.
4. To carry out early identification, intervention and inclusion.
5. To provide support in the implementation of inclusive education at primary, higher and post-matric level.
6. To generate awareness among the family members and community regarding intervention with disabled people.
7. To be aware of legislation on disability and development schemes and concessions to person with disabilities.
8. To understand the importance and strategies for resource mobilization.



DLL in this regard is on track of providing such type of Rehabilitation Courses and programs for the benefit of people especially for the youth who are in need of such type of support.

Directorate Organized Teacher Training Workshop on Inclusive Education

During the current year (2011), the Directorate of Lifelong Learning has launched certain programmes in the field of inclusive education. These programmes include certain diploma courses and few awareness programmes in the concerned field. As one of its community development initiatives, the Directorate conducted "Teacher Training Workshop on Inclusive Education" on 18th December 2010 in Community Development Centre (CDC) at Boys Higher Secondary School Baramulla.

The key objective of the workshop was to make education accessible to differently able children through the linkages of teacher community. The main focus of the programme was to orient the target group about the concept of inclusive education, also to educate them about the identification of such children in the general educational setup.



The programme was attended by a huge number of teachers from various levels of school education especially from District Baramulla. The function was also graced by the galaxy of personnel from various Departments and organizations like the Department of Education, Department of Rural Development, Social Welfare Department and the Department of Civil Defence, J & K Government. An expert guidance regarding the disabilities and preventive measures was thoroughly discussed by the experts from the Composite Regional Centre Srinagar. The importance of inclusive education in the present day was highlighted by the Director, Directorate of



Lifelong Learning Dr. Neelofer Khan whereas the Chief Education Officer Baramulla delivered a lecture on the role of the teacher for helping the differently able children in schools.

The training programme was also attended by the faculty & staff of DLL and the Composite Regional Centre (CRC), Srinagar, various other dignitaries, principals of neighbouring schools, members of civil society and many educationists of the valley.



While interacting with the teachers and experts, Chief Education Officer Baramulla, expressed satisfaction over such initiatives by the University through DLL and thanked the Vice Chancellor, Kashmir University for his mission in the rehabilitation of differently able children especially at the school level. He urged the University authorities to conduct such valuable programmes regularly in future also. He assured the dignitaries for the full cooperation and support from School education and also urged the teachers to make conventional education not just available but accessible, affordable and appropriate for students with disabilities. He further added that schools should have accessibility to such kind of education which will benefit the differently able children.

Objectives

1. To orient the teachers about the concept of inclusive education.
2. To train the teachers about the causes and prevention of disability in children.
3. To provide knowledge among the teachers regarding the Mental Retardation in children.
4. To assist them to differentiate conventional education from Inclusive Education.
5. To provide skills and training to tackle the children of special needs.

Workshop on Classroom Management for Differently Able Children

The Workshop on "Classroom Management of Differently able Children" was organized by Directorate of Lifelong Learning, University of Kashmir in collaboration with Post Graduate Department of Psychology, University of Kashmir. The Workshop was organized at



Block Resource Centre (BRC) Pulwama on 10th of February 2011. The key objective of the workshop was to provide knowledge to teacher community regarding the management of Differently Able Children in the general classrooms. To create favourable environment and to motivate differently able children in mainstream education includes all aspects of education which are applied to such children who are physically and mentally challenged, and are otherwise disadvantaged.

The programme was attended by Additional Deputy Commissioner Pulwama, Block Development Officer, Chief Medical Officer, Chief Education Officer, and Zonal Education Officer of District Pulwama. Officials from the various Government Departments including Directorate of Health Services, Department of Rural Development, and Directorate of School Education, J&K Government, various members from the local community and the civil administration also participated in the workshop. While inaugurating the workshop, the ADC, Pulwama emphasized on the awareness of such issue and said that it is a need of the hour to take concrete steps in order to have better future for this class of community. He also stressed upon the importance of teacher in planning and organizing a class room management of differently able children. Speaking on the Occasion, Head, Department of Psychology, University of Kashmir deliberated upon the psycho-social problems of the differently able children. The workshop was divided into various sessions and in each session various disability issues were focused by the experts on the specialized fields. In the workshop various types of child disabilities i.e. mental retardation, visual and hearing impairments and their classroom issues & management were discussed between the teachers and the resource persons. It was added that the differently able children should have accessibility to such kind of education which will benefit them and they will also feel as the equal part of the society without any discrimination.

The main finding of the programme was to raise the awareness level of the community in general and that of the parents in particular to make the inclusive education a successful venture and truly exploit the inner and hidden potentialities in question to ensure the balanced development.

DLL Ventured National Level Experts to Coach 2011 AIEEE Aspirants

As per the demand of the students and the parents, the Directorate conducted the AIEEE counselling-cum-coaching during the current year also. The programme was basically conducted because of the best results achieved by DLL in the previous counselling programme which was held in the year 2010 and the reference has already been given in this publication also. This programme was conducted in collaboration with India's leading group in



imparting the trainings and skills to face the competitive examinations. This group works under the banner of "Tutorials for Success" (TFS) and is operational from New Delhi in various States of the country. The counselling went successful because of the toil and hard work of DLL faculty and the initiatives taken by the Worthy Vice Chancellor. The programme was conducted during the month of Jan-Feb 2011. The students were provided simplified and result oriented coaching academically. They were rigorously oriented with the practice sheets containing the objective as well as subjective type of questions. They were put to testing frequently in accordance to the AIEEE question formats so as to familiarize them with the competitive examination setup. The newer strategies were put into practice which includes problem solving counters, periodic tests, timely upgrading system, limited batch strength, periodic academic and psychological counselling and the scheme of rewards and scholarship assignments. The unique feature of the

With the mission to develop community and help the under- privileged sections of the society, the Directorate of Lifelong Learning (DLL), University

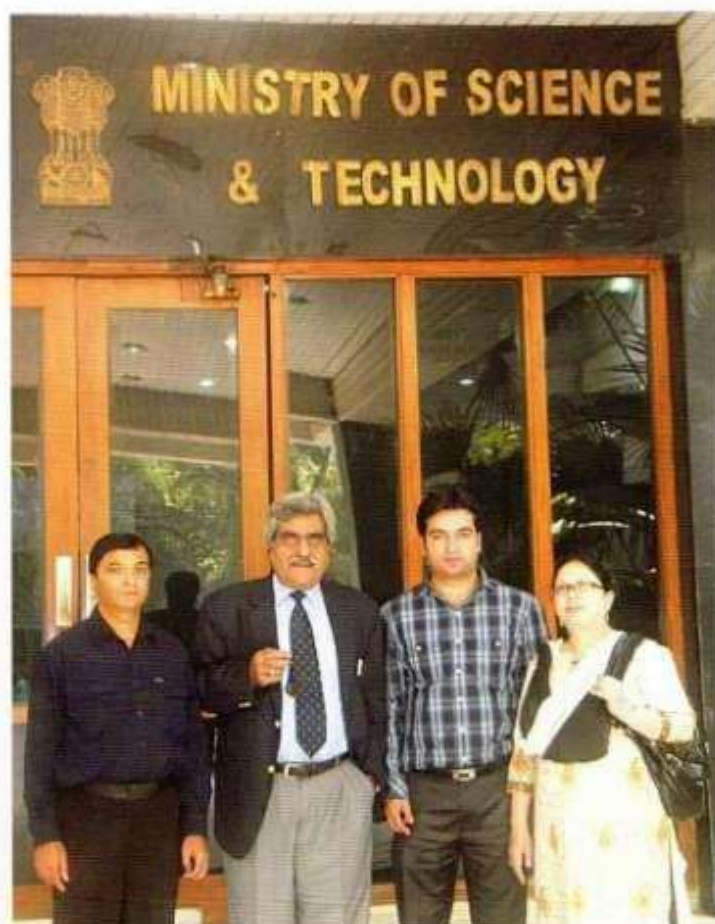


of Kashmir is at the forefront. With this goal into consideration, DLL submitted various project proposals to some of the National and International organisations. One of the proposals was submitted to UNICEF for considering the unconcerned state of affairs of girls and women in Kashmir especially those who belong to the backward and marginalized areas of

this region. The conflict situation for more than two decades in the valley brought unprecedented gloom in all spheres of lives of the people in Kashmir in general and crippled the lives of most of the girls and women in particular. This has shattered and shaken the socio-economic, educational, cultural, scientific fabric of the region. Despite various odds, the University of Kashmir through Directorate of Lifelong Learning facilitated many outreach activities to bring change in the lives of common masses. Hence a proposal regarding their upliftment for better change was submitted to United Nations Children's Fund (UNICEF) for the greater benefit of the disadvantaged folk of women at large. Under these circumstances the entire women folk in far flung and border areas of valley need to be empowered in realms of education, healthcare, constitutional rights and the skills which will earn them independent economy that will inturn develop a path to women empowerment. Learning, University of Kashmir desires to focus its activities towards the girls and women, the deprived lot especially to provide them the skills in order to empower them.

Similarly, Directorate approached Department of Science & Technology (DST) Government of India with a project that will benefit the student community at large which includes conduct of multidimensional programmes

through non-formal system in terms of providing professional/ vocational, entrepreneurship development courses, trainings, workshops, seminars, conferences, counselling/coaching, continuing education programmes, and awareness generation for overall development of the community.

With a concern towards the rehabilitation of certain target group in the community, Directorate approached the Rehabilitation Council of India (RCI) for their cooperation in establishing the Diploma Courses in Community Rehabilitation. The chairman RCI in this connection showed a realistic positive approach towards the initiative taken by the Directorate and hailed the efforts in this regard. 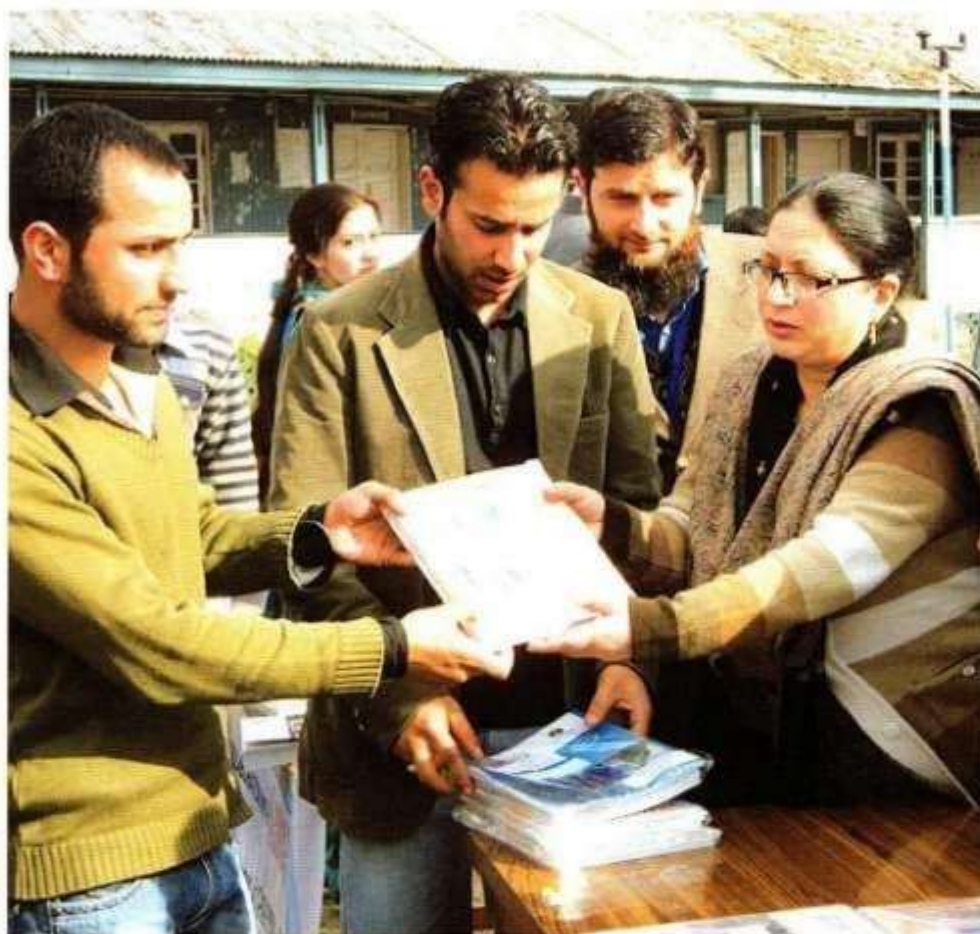

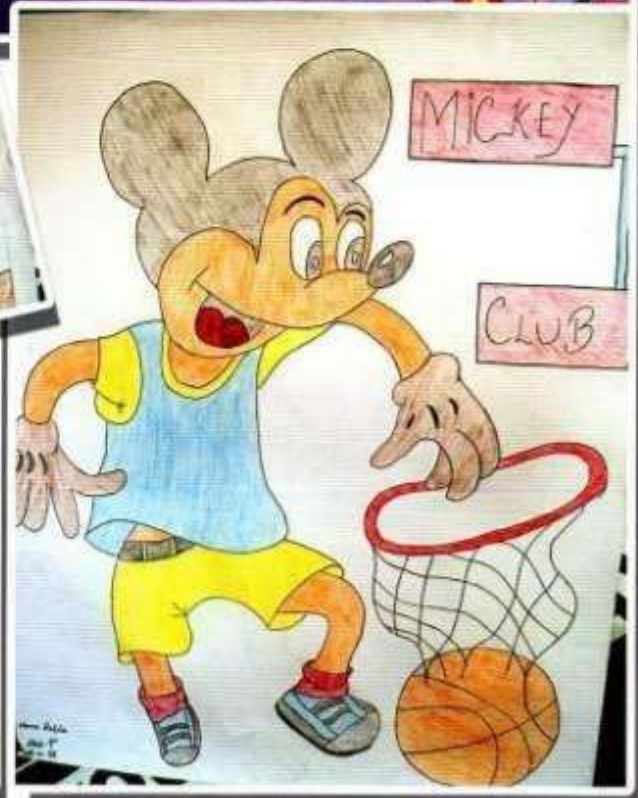

Centrality of Literacy

Literacy is a key to people's empowerment in the spheres of social, economic, cultural and political development of communities. It is necessary to prioritize actual and comprehensive learning over numerical aims if valuable investment is desired. To achieve this, it is essential to provide literacy with professional development opportunities in order to develop sustained linkages between literacy programmes, the interests and felt educational needs of young people and the community. The literacy initiatives should be the demand of the most excluded sections and also the elite class who suffer at educo-professional planes of their personality. Broadly speaking, literacy is more than deciphering character and is not confined to mere achievement of 3 R's-Reading, Writing and Numeracy. It has four major objectives namely literacy (read and write with comprehension), numeracy (ability to calculate and do daily life operations), functionality (utilizing knowledge for practical purposes) and awareness (application of the skills for the betterment of oneself and the society). Awareness, by the underprivileged, of the reasons for their present deprived status and improving it through participation in the development process is an important implication of functional literacy. As early as 1988, a document on national literacy mission (NLM) suggests that the objectives of functional literacy would be facilitation of skills and improve economic status and general wellbeing, imbibing various values and importantly social awareness of the causes of deprivation and organization for participation in development. The real development of a nation is to be assessed in terms of meaningful participation of the masses or mass involvement in multiple social, economic and political processes of the country and the resultant benefits arise out of the participatory approach. However, the manifestation of inadequate participation in the developmental endeavours and initiatives created incompatible conditions among the people for generating a culture of development and made them mute and passive spectators. The empirical studies explicitly reveal that illiteracy is the severe hindrance which is responsible for non-participation, perpetual in confidence,

poor quality of life, lack of general understanding of contemporary issues, limited world view, gender bias, poor health status, high birth and death rates, drug addiction, superstition approach and other social evils which ultimately lead to the incapacitated people to live at the bottom of social structure. Precisely, illiteracy is the root of contemporary underdevelopment, is the major handicap which narrows down vision of citizens to play an effective role and their participation in welfare programmes. There should be united national endeavour and effort to infuse the importance of literacy in collective psyche of the people as a permanent individual, social and national necessity to promote conducive learning environment. This will virtually enable and empower the people to express their ideas, feelings, thoughts, perceptions and opinions freely and break the barriers of alienation, isolation and marginalization. Obviously, it would change the outlook and bring a glow of liberation in the dark and bleak existence of the people. The writings of Noble Laureate Prof. Amartya Sen have shed new light on literacy for real freedom. It according to him has powerful effect on the quality of life, freedom to enjoy, understanding the world to communicate and to interact with each other. Literacy, so to speak, is an indispensable window on to the surroundings, changing society to horizons beyond household and ensures accessibility to multiplicity of life and society. So in the present context, literacy has a wider meaning and greater role to play. There is no gainsaying the fact that literacy would develop a sense of purpose and confidence essential for building a dynamic, vibrant and cohesive nation capable of providing its people with the wherewithal for creating better, fuller and more purposeful life and creating a national environment for peaceful harmonious development. The literacy initiatives played very important role in the enrichment of dispossessed and rejuvenated collective life, consciousness and confidence of the people. Poverty stricken class of peasants and artisans during feudal economy had undercurrents of deep frustration towards life and society at the hands of money lenders and Sahukars. Debts were written and re-written resulting in lifelong bondage of the people. Thus the literacy skills and the light of learning proved instrumental for their emancipation from the clutches of oppressors. The Dalits of village jillela, District Karnol of Andhra Pradesh were being used as bonded labourers. The literacy programme awakened them to fight for their rights and obtained full wages from their masters. In Boxibarigaon, a village in Orissa, the tribals used to be afraid to speak before visiting Government officials. But the adult literacy programme broke their culture of silence and made them conscious of their rights and they demanded arrangement for

electrification, better transport facilities, establishment of primary health centre. In Pudukottai District of Tamilnadu, the total literacy campaign (TLC), not only achieved 90% literacy in the target groups within eight months but also improved the status of women. They were given training in non-traditional skills like cycling, welding, gem cutting etc. The major spin off from the campaign was the release of quarry workers from the clutches of contractors. The literacy programme at Sripuram village, District Nellore, Andhra Pradesh had become a talisman for the women who had given them prized possession namely the determination to live with dignity and to fight the indignity of impoverishment caused by liquor. They not only changed the men who eventually gave up drinking but also closed down the liquor shops. The literacy not only determines the quality of life of the people in the society but also gives an idea about the competence of that society to adapt to the fast changing world. It can be clearly pointed out when our culture is compared with the western culture. The people of western countries enjoy freedom and liberty to a greater extent to that of ours. This discrepancy does not originate from richness rather it is the level of literacy which determines the degree of freedom and liberty available for the citizens of a country. All round development of human civilization is realized when the people have liberty in social, economic, political fields and this is materialized only when all the people are literate enough to think comprehensively about their own welfare. Thus, literacy is the pre-requisite to enter the gateway of lifelong learning with a view to meet the demands of knowledge society and to facilitate the process of developing a learning society.

Visually Impaired and Societal Outlook

In ancient or economically marginal societies, blind infants were usually discouraged for survival of their lives. It was believed that impaired infants would become burden to their lives. There are number of views concerning the visually impaired people, some believe that they are dependant while others treat them as destitutes and some treat them as beggars. Some religious beliefs equate blindness with the state of darkness and void. A few religions explain blindness as occurrence caused by sin committed in one's past life, while others believe it as a kind of suffering which leads to purification and eventual betterment of a person in his spiritual life. There are chiefly two key societal attitudes towards the blind.

One view links it with helplessness, sense of desolation and misery while the other perspective belief is that blinds possess extraordinary intellectual and spiritual power. The former view seems to be non-pragmatic in approach. Coping with such negative attitudes is often a greater challenge for blind person than with his impairment. Some people believe that the lack of vision endows an individual with supernatural abilities such as sharpness of hearing and touch or some artistic ability. The family plays an important role in shaping one's personality. They provide the first social environment in child's life. Culture, socio-economic status, education of the family and the relation of the parent with his visually handicapped child determine the level and quality of adjustment of the child to his own disability and to the society. The role of the parents especially the mother is regarded as the most crucial in this process. A family which is steeped in an orthodox culture follows a fixed system of belief and authoritarian outlook which tends to transmit rigid attitude to its members who also are resistant to any change in the existing systems to meet the demands of a new situation. The family relation being all pervasive and rightly motivating its rejection of the child's disability by the family depends on the closeness and openness of the society of which it is a unit.

A child is dependent on parents in the family not for food and shelter but also for protection, approval and affection. When the parents of visually impairment child show disinterest or express hostility towards such special children, they feel dejected. For some parents, the child's impairment represents frustration of their own aspirations. If the parents feel guilty about the blindness they project their own guilt upon the child, finding fault with it or becoming angry with it. The family who accepts a visually handicap member with all his potentials and limitations without imposing any of its own attitude on him, can help him or her to recognize in the most desirable way. It is true that to accept dispassionately a member's blindness requires a high degree of emotional restraint on the part of the parent and other members of the family, but there is no other way to complement it.

The rate of drop outs at 10th standard level is estimated millions every year at National level which instantly increase their inaccessibility to global society in view of their shortage of skill. Therefore there is urgent necessity to equip the youth with the skill in order to make them viable and vibrant players in the global economic order.

It is the duty of educationist and administrators to counsel and guide the student's and the youth at the school level and should design some courses according to their abilities, interests and innovations which can eradicate the shackles of ignorance and will enlighten our intellect with knowledge and power. Similarly by creating guidance and counselling cells, seminars, extension programmes and competitions we can properly channel and guide our youth to use their talent and capabilities in such away that they choose most right and appropriate path through which they can fulfil their dreams and can contribute towards development of the society.

The need of hour is to provide easy access to current information and technologies in their field of interests for which we have to update and modify our information, database and documentation centres including libraries etc. that they can serve the purpose of the needy. Our syllabus, curriculum, method of teaching and other academic arrangements should be focused on the betterment of the youth. Civic participations, governance, encouragement from our elders in developing life skills, training or information on livelihood opportunities will lead proper and fruitful empowerment of the youth. In addition to this, launch of media campaigns for the empowerment of the youth in total can do wonders in their development and better future perspectives.



Meaning of Life Satisfaction and Statistics among Women in Kashmir

Satisfaction is a Latin word which means to make or do enough. Satisfaction of life implies contentment with or acceptance of one's life or the fulfilment of all basic needs as a whole. Life satisfaction has been described as the harmony of desired goals, which are and ought to be achieved in life. Explaining life satisfaction as quality of life indicates general well being. Quality of life is the physical fitness (actual and perceived by the individual), psychological health (low on loneliness, helplessness and high on life satisfaction) as well as the leisure time activities and social support network derived from the environment by an individual. In other words, it can be defined as the perception and attitude of a person with his past as well as with the present circumstances. The satisfaction of life can be increased by the fulfilment of the requirements and needs, by being active in participation and by being away from the chaos, anxiety and depression of life. However, life satisfaction can get declined due to loss of spouse, bread earner, health and wealth in the life of an individual.

The new studies explore people's subjective well-being. Subjective well-being or happiness, have both an affective (emotional) and a cognitive (judgmental) component. The former consists of individual's positive and negative experiences. Comparisons between how things are and what one wants, what one had, what one expected, what others have, and what one feels one deserves combine to determine life satisfaction. Researchers differentiate between life-domain satisfaction and life-as-a whole (or global) life satisfaction. Life-domain satisfaction refers to satisfaction with specific areas of an individual's life, such as work, marriage, and income, whereas judgments of global life satisfaction are much more broad, consisting of an individual's comprehensive judgment of her life. Indeed, objective measures of quality of life e.g income or education are often related to people's subjective self-reports of the extent to which they are satisfied with their lives. It also appears to vary with other cultural dimensions. Satisfaction is determined by one's perceptions of "how things are" Vs "how they should be." Frequent positive effect, infrequent negative effect and a global sense of satisfaction with life defines life satisfaction of an individual; better clues to satisfaction with life comes from knowing about the person's traits, relationships, work experiences and culture. The conceptualizations of life satisfaction proposed





by theorists in this area offer several clues e.g it is the difference between what one wants and what one has, essentially comparison between reality and the ideal. A great deal of work has investigated whether life satisfaction is stable, enduring trait or it is variable and highly influenced by external events and life circumstances.

Although most research on life satisfaction has not been directly focused on the experiences of women, a few studies have investigated the unique indicators of life satisfaction in women. Though the life satisfaction of the general mass has been widely researched and discussed, most researchers investigating the indicators of life satisfaction have not specifically focused on the experiences of women in Kashmir whose life has been disrupted due to conflict in valley. The purpose of this study is to expand further the scope of previous studies done in this regard. It also aims to examine the relationship between life satisfaction and specific situational variables directly affecting the life satisfaction of the sample group.

Though the life satisfaction of the general masses has been widely researched and discussed, most researches investigating the predictors of life satisfaction have not specifically focused on the experiences of women & children affected by armed conflict in Kashmir. In order to study the life satisfaction of women & children beneficiaries receiving assistance from voluntary organizations "Life Satisfaction Scale" was administered on 300 women affected by armed conflict in Kashmir. In order to get a clear depiction of various parameters, variables like age, monthly income, educational qualification, marital status, cash assistance & family context correlation statistics were used. Value of Chi square reveals that there is a significant difference in life satisfaction scale scores across various Districts of Kashmir Division. In Anantnag, Kupwara and Budgam Districts of valley, a large majority of respondents (78%, 96% and 80% respectively) revealed high life satisfaction while in Pulwama and Srinagar, 58% and 54% respondents scored high on life satisfaction scale. Lowest number of respondents of Baramulla as compared to all other Districts scored high on life satisfaction scale. This could be attributed to the fact that Baramulla district has witnessed intense violence in the recent years.

Correlation statistics of women beneficiaries reveal negative correlation between age & life satisfaction scores in all five districts of Kashmir except in Kupwara which indicates that higher the age the lower the level of life satisfaction. The reason for this could be that as age increases, many aspects of life decline due to less work opportunities, lower financial security, restricted social activities & deteriorating physical health which may affect the life satisfaction of an individual. Due to conflict in Kashmir, there has been disrupted family structure & lack of family support which could adversely affect life satisfaction of victimized women. According to the respondents it was

found that as age increases, closeness with spouse escalates life satisfaction, but in the context of change in relation (death or disappearance of spouse) life satisfaction tends to decrease. Although overall association of life satisfaction scale scores with education was comparatively weak & insignificant, positive correlation was found between life satisfaction scores & education in Kupwara, Pulwama & Budgam, whereas negative correlation was seen in district Srinagar, Baramulla & Anantnag. It was, however, reported by many respondents that if they would have studied, things would have been different in their lives – they would have an access to property, awareness about their rights & various schemes which could benefit them. During data collection, the investigator came across victimized women who were ready to migrate to Srinagar city to gain vocational education. On the other side, many voluntary organizations wanted to provide small scale shops to women for generating income, which the respondents were reluctant to receive, reason being that they felt that they couldn't handle the dealings due to lack of education. It was a common perception among women that even a slightest increase in education helps in raising the status of the person in the community.

Negative correlation between monthly income & life satisfaction scores was found in Kupwara, Pulwama, Budgam & Baramulla Districts, whereas positive correlation was found in Srinagar & Anantnag. Kupwara & Baramulla being nearer to the border (LOC) are the worst hit areas of the valley. Overall, significant positive correlation was observed between cash assistance & life satisfaction scores in Pulwama district while significant negative correlations were observed between age & life satisfaction scores in districts Baramulla & Anantnag. Similarly significant negative correlations were observed between monthly income & life satisfaction scores in District Pulwama & Budgam. However positive correlation was found between cash assistance provided by the voluntary organizations & life satisfaction scores in Srinagar, Pulwama & Anantnag, whereas negative correlation was found in Kupwara, Budgam & Baramulla districts. Voluntary organizations working in District Pulwama are providing livelihood incentives which help the women to generate income & live a dignified life. Positive correlation was found between number of dependents & life satisfaction scores in Kupwara & Budgam, whereas negative correlation was found in District Srinagar, Pulwama, and Baramulla & Anantnag. The difference could be due to the difficulties that women are facing due to large family structure. Women with minimal resources find it difficult to shoulder the responsibilities of large family. In contrast, the factors that might lead to positive correlation could be sense of security, connectivity, closeness in the family which predicts more self confidence & higher life satisfaction.

Leaflets, folders, brochures etc. can also prove communicative for the neo-literates. Graphical materials, displays and projected aids can be utilized in accordance with age, ability and experience of the learners. The key purpose of education is communication of skills, knowledge and attitudes. Therefore mass media has the potential in communicating these effectively. The media communication has opened new dimension in the horizon of human world. By application of various media in the field of education, millions of people have come to acquire new ideas, philosophies, approaches and attitudes. Broadcasting education has a significant role to play in promoting education and development. The role is more substantial in the context of situations in developing countries like India which are facing on the one hand with the problem of huge percentage of illiteracy and heavy dropout rates on the other.
